



On approval of the Rules for the award of an educational grant to pay for higher or postgraduate education with the award of the degree of "Bachelor" or "Master"

The order of the Government of the Republic of Kazakhstan of January 23, 2008 N 58.

Pursuant to the Law of the Republic of Kazakhstan dated July 27, 2007 "On Education", the Government of the Republic of Kazakhstan DECIDES:

1. To approve the attached Rules for the award of an educational grant for the payment of higher or postgraduate education with the award of a "bachelor" or "master" degree.

2. To recognize as invalid some decisions of the Government of the Republic of Kazakhstan in accordance with the annex to this resolution.

Chapter 4. The procedure for awarding vacant educational grants to pay for higher or postgraduate education with the award of a "bachelor" or "master" degree, released in the process of obtaining a higher or postgraduate education

24. Vacant educational grants that were released in the process of obtaining higher or postgraduate education (hereinafter referred to as vacant grants) are awarded on a competitive basis to students on a paid basis in groups of educational programs.

The competition is held according to the results of interim certification based on the GPA (Grade Point Average - Grade Point Average) with the issuance of an educational grant certificate.

An open tender announcement is posted on the University website (educational portal) indicating the number of vacant educational grants in the context of the training direction and course.

In the case of the same GPA indicators (Grade Point Average - Great Point Everage), the priority is given to students with grades of only A, A- ("excellent"), then grades from A, A- ("excellent") to B +, B, B-, C + ("good"), then mixed estimates for the entire training period.

Awarding of vacant educational grants that were released in the process of obtaining higher and (or) postgraduate education is carried out during the summer and winter holidays to the available vacant places on a competitive basis in the following order:

- 1) the student on a fee basis submits an application addressed to the head of the University for further training on an educational grant of higher or postgraduate education;

- 2) received applications are considered at a meeting of the academic (academic) council and the supervisory (trustee) council and (or) the board of directors;

- 3) University on the basis of the decision of the academic (academic) council and the supervisory (board) of trust and (or) the board of directors, by August 5 and January 15 of the current year, sends a list of applicants for transfer to vacant educational grants to the authorized body in the field of education for adoption solutions.

The copy of the student's statement, the decision of the academic (academic) council and the supervisory (board) of directors and (or) the board of directors, an extract from the student's transcript, a copy of the document proving his identity, and a certificate of the holder of the educational grant (original) expelled from the University are attached to the list ;

- 4) vacant educational grants, released in the process of obtaining higher and (or) postgraduate education and submitted to the authorized body in the field of education in the absence of applicants, are redistributed by the commission on a competitive basis;

- 5) a list of vacant educational grants that were released in the process of obtaining higher and (or) postgraduate education and submitted by the University due to the lack of applicants is published on the website of the authorized body in the field of education;

6) the competition is held among students on a fee basis from other universities that have submitted documents for participation in the competition, in the context of groups of educational programs, courses based on the results of intermediate certification;

7) the authorized body in the field of education considers the submitted documents in the context of groups of educational programs, forms and terms of study, taking into account the year of admission and, with a positive decision, issues an order for the award of a vacant educational grant of higher and (or) postgraduate education (in the absence of applicants for the group of educational programs, vacant educational grants released in the process of obtaining higher and (or) postgraduate education are redistributed within the direction of otovki or field of education);

8) on the basis of the order of the authorized body in the field of education, the NTC draws up a certificate on the award of an educational grant and transfers it to the appropriate University within 3 working days;

9) on the basis of the issued certificate on the award of an educational grant, the head of the University issues an order for further training on an educational grant.

25. The first head of the University is responsible for the timely return to the authorized body in the field of education of unused vacant educational grants, released in the process of obtaining higher and (or) postgraduate education, to the authorized body in the field of education.
