

Title of the project: №AP08855487 “State-confessional relations in Kazakhstan: the beginning of the XX century - the end of the 1930s”

Actuality: The issue of relations between the state and religious associations is one of the most debated at present, since the influence of religious organizations on the mood of citizens and public processes as a whole is constantly growing. On the one hand, religious organizations are active in promoting social initiatives, which, of course, gives them credibility and trust on the part of the population. On the other hand, there is a noticeable increase in manifestations of religious extremism, which negatively affects the state of society. Therefore, the historical experience of relations between the state and confessions in different periods of history is of great scientific interest and is useful for developing a strategy in matters of state-confessional interaction.

For the Kazakhstani multiethnic and multiconfessional society, the issue of interaction of the state with faiths has been and remains relevant, especially at present. The issue of religious freedom belongs to the category of complex ones, since in the context of the intensification of religious life, cultural differences within the state may intensify, there is a likelihood of ethno-confessional extremism, separatism and their negative consequences.

The purpose of the project

The aim of the project - on the bases of analysis of scientific literature, study the evolution of various published and unpublished archival sources of state-confessional relations at different stages of development of society (in the pre-revolutionary period and in the period of profound transformation of the socio-political system of the state after 1917) for the summarization of historical experience, preparation of scientific publications on the problem.

The following results are expected to be obtained

Based on the results of the research and the results obtained, it is expected to publish scientific articles in the following publications:

- 2 articles in publications included in the Scopus database (the Cite Score percentile in the Scopus database is at least 35 (thirty-five) and / or Web of Science (Q1-Q3);
- 4 articles in Kazakhstani scientific journals recommended by the Quality Assurance Committee in the field of education and science of the Ministry of Education and Science of the Republic of Kazakhstan;
- 3 articles in Russian publications included in the RSCI database;
- 2 articles in materials of international conferences, research results will be reported at international conferences.
